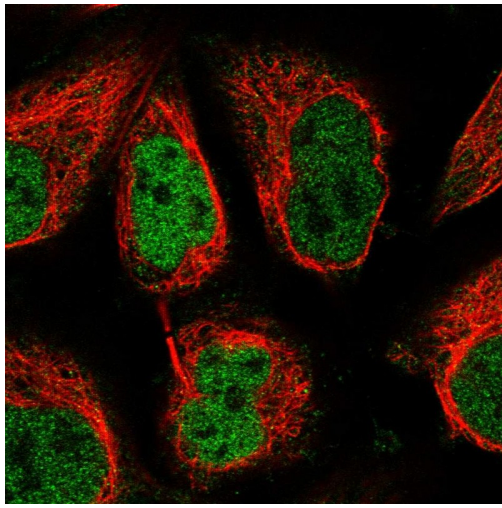

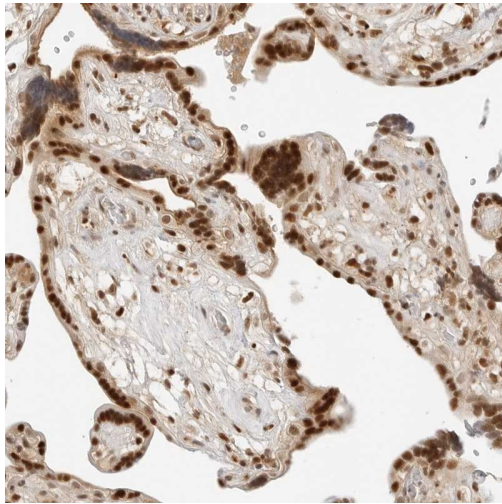

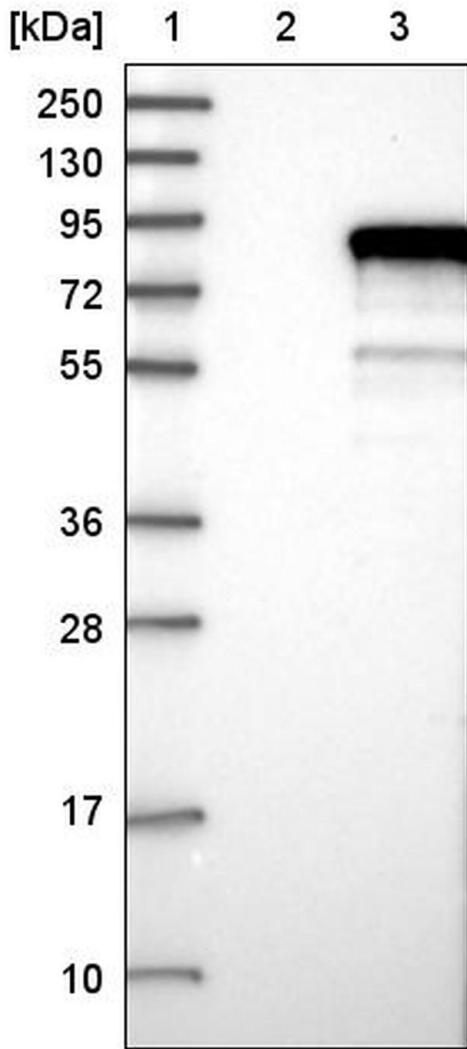


Torc2 Antibody (PA5-83015) in IHC
