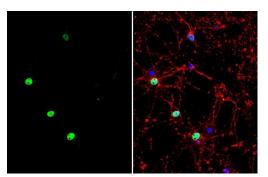
Keep as concentrated solution.

Positive Control: mouse fetal brain.

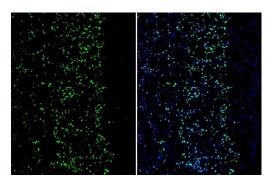
Store product as a concentrated solution. Centrifuge briefly prior to opening the vial.

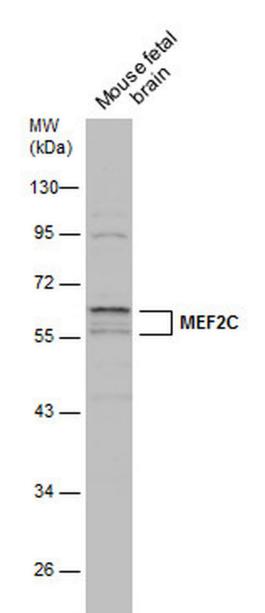
#### Phospho-MEF2C (Thr20) Antibody (PA5-85300) in ICC/IF

Immunocytochemistry-Immunofluorescence analysis of Phospho-MEF2C-(Thr20) was performed in DIV10 rat E18 primary cortical neuron cells fixed in 4% paraformaldehyde at RT for 15 min. Green: Phospho-MEF2C (Thr20) Polyclonal Antibody (Product # PA5-85300) diluted at 1:500. Red: beta Tubulin 3/ Tuj1, stained by beta Tubulin 3/ Tuj1 antibody. Blue: Fluoroshield with DAPI.

Immunohistochemistry (Frozen) analysis of Phospho-MEF2C-(Thr20) was performed in frozen-sectioned mouse cerebral cortex tissue using Phospho-MEF2C (Thr20) Polyclonal Antibody (Product # PA5-85300) at a dilution of 1:250 (Green). Blue: Fluoroshield with DAPI.

Western blot analysis of Phospho-MEF2C (Thr20) in mouse tissue extract using Phospho-MEF2C (Thr20) polyclonal antibody (Product # PA5-85300) using 50 µg of sample at a dilution of 1:1000. Prior to incubation with primary antibody, the sample was separated on 10% SDS-PAGE.
