

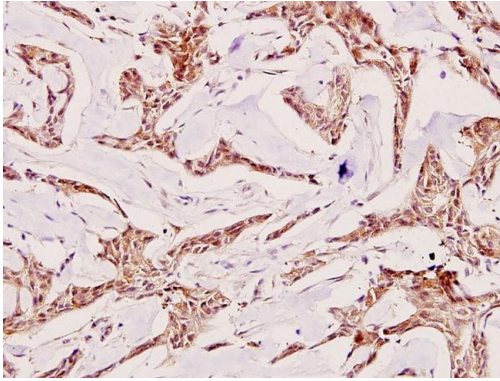

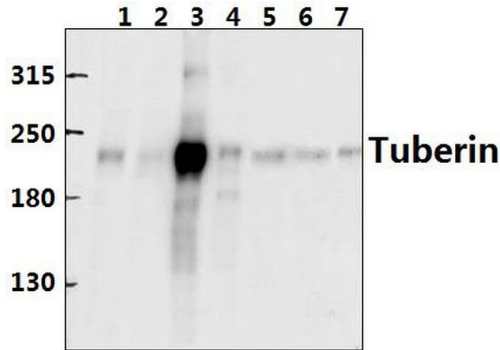

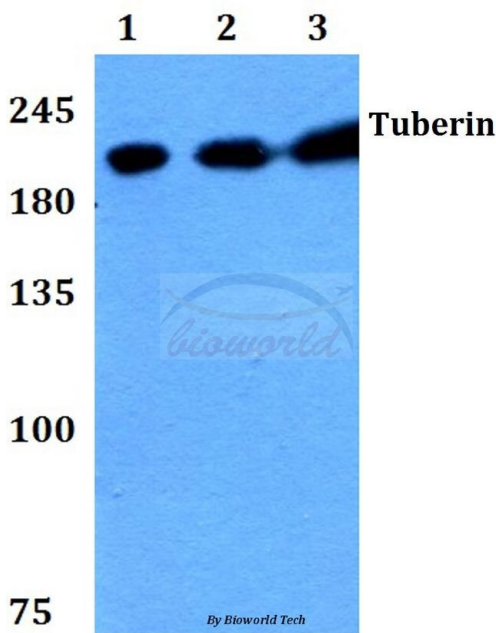
TSC2 Antibody (PA5-86305) in IHC (P)
