




Dystrophin Antibody (PA5-89628) in WB

Western blot was performed using Dystrophin Polyclonal Antibody (Product # PA5-89628) and bands around 460 kDa corresponding to dystrophin were observed. Tissue extracts (30 µg lysate) of Mouse Heart (Lane 1) and Rat Heart (Lane 2) were electrophoresed using NuPAGETM 3-8% Tris-Acetate Protein Gel (Product # EA0378BOX), 10 well. Resolved proteins were then transferred onto a nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (1:1000) and detected by chemiluminescence with Goat anti-Rabbit IgG (Heavy Chain) SuperclonalTM Recombinant Secondary Antibody, HRP (Product # A27036, 1: 20,000) using the iBrightTM FL1500 Imaging System (Product # A44115). Chemiluminescent detection was performed using SuperSignalTM West Pico PLUS Chemiluminescent Substrate (Product # 34580).

Lysates/proteins: 25 µg per lane. Blocking buffer: 3% nonfat dry milk in TBST. Detection: ECL Basic Kit. Exposure time: 10s.
