




# SIRT3 Antibody (PA5-96406)

Antibody specificity was demonstrated by siRNA mediated knockdown of target protein. Hep G2 cells were transfected with NAD-dependent protein deacetylase sirtuin-3, mitochondrial siRNA and decrease in signal intensity was observed in Western Blot application using Anti-SIRT3 Polyclonal Antibody (Product # PA5-96406). {KD}



#### SIRT3 Antibody (PA5-96406) in WB

Western blot was performed using Anti-SIRT3 Polyclonal Antibody (Product # PA5-96406) and a 28 kDa band corresponding to NAD-dependent protein deacetylase sirtuin-3, mitochondrial was observed across cell lines tested. Whole cell extracts (30 µg lysate) of Hep G2 (Lane 1), HeLa (Lane 2), MCF7 (Lane 3), A-431 (Lane 4), Raji (Lane 5) were electrophoresed using NuPAGE™ 12% Bis-Tris Protein Gel (Product # NP0341BOX). Resolved proteins were then transferred onto a nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (1: 750 dilution) and detected by chemiluminescence with Goat anti-Rabbit IgG (Heavy Chain) Superclonal™ Recombinant Secondary Antibody, HRP (Product # A27036,1:4000 dilution) using the iBright FL 1000 (Product # A32752). Chemiluminescent Substrate Reagent Kit (Product # WP20005).



#### SIRT3 Antibody (PA5-96406) in WB

Western blot analysis of SIRT3 in extracts of various cell lines. Samples were incubated with SIRT3 Polyclonal antibody (Product # PA5-96406) using a dilution of 1:1,000, followed by HRP Goat Anti-Rabbit IgG (H+L) at a dilution of 1:10,000. Lysates/proteins: 25 µg per lane. Blocking buffer: 3% nonfat dry milk in TBST. Detection: ECL Basic Kit. Exposure time: 10s.
