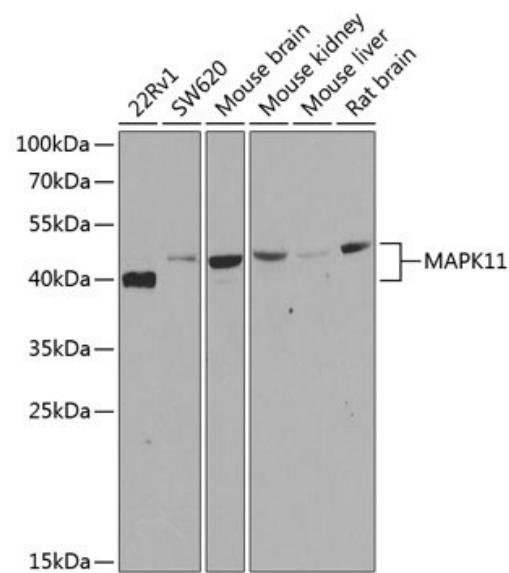

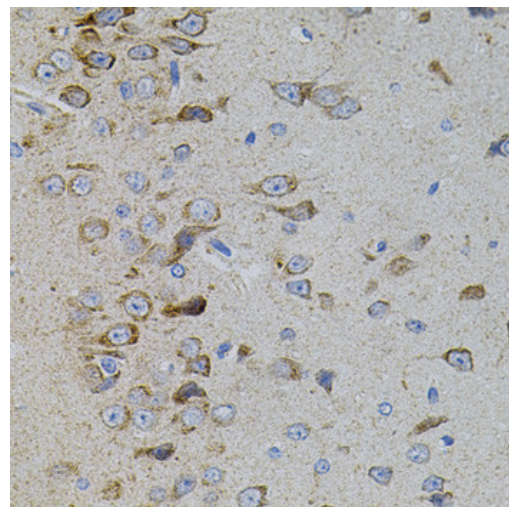

Western blot analysis of p38 MAPK beta in extracts of various cell lines. Samples were incubated with p38 MAPK beta Polyclonal antibody (Product # PA5-96773) using a dilution of 1:500, followed by HRP Goat Anti-Rabbit IgG (H+L) at a dilution of 1:10,000. Lysates/proteins: 25 µg per lane. Blocking buffer: 3% nonfat dry milk in TBST. Detection: ECL Basic Kit. Exposure time: 90s.
