





Immunofluorescent analysis of TCN2 in U251 cells using a TCN2 polyclonal antibody (Product # PA5-98188) at a dilution of 1:100. Alexa Fluor 488-congugated Goat Anti-Rabbit IgG(H+L) secondary antibody was used.

Western Blot analysis of TCN2 using a TCN2 Polyclonal antibody (Product # PA5-98188) at a concentration of 3.5 µg/mL. Positive WB detected in: HEK293 whole cell lysate. A secondary Goat polyclonal antibody to rabbit IgG was applied at a 1:50,000 dilution. Observed band size: 48 kDa.
