






BAP31 Antibody (PA5-98269) in WB

Western Blot analysis of BAP31 using a BAP31 Polyclonal antibody (Product # PA5-98269) at a concentration of 4.8 µg/mL. Positive WB detected in: 293 whole cell lysate, Hela whole cell lysate, MCF-7 whole cell lysate, SH-SY5Y whole cell lysate, Rat lung tissue, Rat brain tissue, Mouse lung tissue, Mouse brain tissue. A secondary Goat polyclonal antibody to rabbit IgG was applied at a 1:50,000 dilution. Observed band size: 28 kDa.



BAP31 Antibody (PA5-98269) in ICC/IF

Immunofluorescent analysis of BAP31 in Hela cells using a BAP31 polyclonal antibody (Product # PA5-98269) at a dilution of 1:400. The cells were fixed in 4% formaldehyde, permeabilized using 0.2% Triton X-100 and blocked in 10% normal Goat Serum. The cells were then incubated with the antibody overnight at 4°C. The secondary antibody was Alexa Fluor 488-congugated Goat Anti-Rabbit IgG(H+L). Cells were counter-stained with DAPI.



BAP31 Antibody (PA5-98269) in IHC (P)

Immunohistochemical analysis of BAP31 in paraffin embedded human prostate cancer using a BAP31 polyclonal antibody (Product # PA5-98269) at a dilution of 1:1200. After dewaxing and hydration, antigen retrieval was mediated by high pressure in a citrate buffer (pH 6.0). Section was blocked with 10% normal goat serum 30min at RT. Then primary antibody (1% BSA) was incubated at 4°C overnight. The primary is detected by a biotinylated secondary antibody and visualized using an HRP conjugated SP system.
