



## CARD11 Antibody (PA5-98868) in WB

Western Blot analysis of CARD11 using a CARD11 Polyclonal antibody (Product # PA5-98868) at a concentration of 4  $\mu$ g/mL. Positive WB detected in K562 whole cell lysate. A secondary Goat polyclonal antibody to rabbit IgG was applied at a 1:10,000 dilution. Observed band size: 133 kDa.
