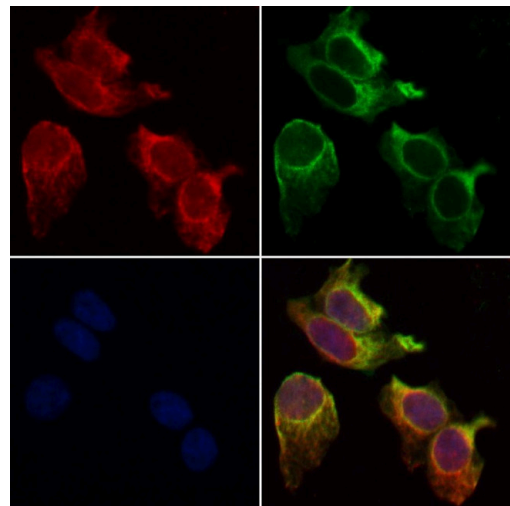

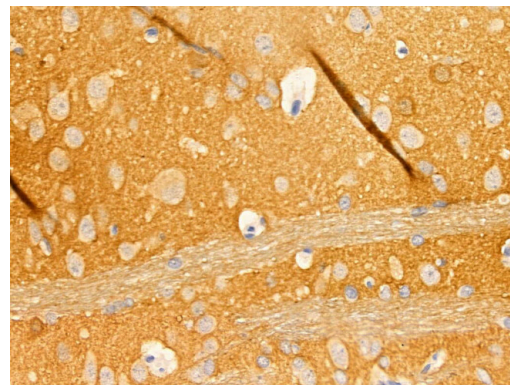

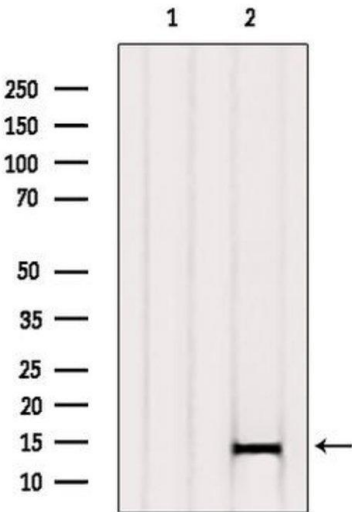
beta Synuclein Antibody (PA5-99453) in ICC/IF

Immunofluorescent analysis of beta Synuclein in HepG2 cells. Samples were fixed with paraformaldehyde, permeabilized with 0.1% Triton X-100, blocked with 10% serum (45 min at 25°C), incubated with mouse anti-beta tubulin and beta Synuclein polyclonal antibody (Product # PA5-99453) using a dilution of 1:200 (1 hr, 37°C), and followed by goat anti-rabbit IgG Alexa Fluor 594 (red) and goat anti-mouse IgG Alexa Fluor 488 (green).



beta Synuclein Antibody (PA5-99453) in IHC (P)

Immunohistochemistry analysis of beta Synuclein in rat lung tissue. The sample was formaldehyde fixed and a heat mediated antigen retrieval step in citrate buffer was performed. Samples were incubated with beta Synuclein polyclonal antibody (Product # PA5-99453) using a dilution of 1:100 (4°C overnight) followed by HRP conjugated anti-Rabbit secondary antibody.

Western blot analysis of beta Synuclein in rat muscle tissue lysate (left lane: treated with blocking peptide). Samples were incubated with beta Synuclein polyclonal antibody (Product # PA5-99453).
