Recommended positive controls: HepG2 conditioned medium. Predicted reactivity: Mouse (80%), Rat (80%), Pig (85%), Bovine (86%). Store product as a concentrated solution. Centrifuge briefly prior to opening the vial.

Background/Target Information

This gene encodes a member of a family of secreted proteins that function in angiogenesis. The encoded protein, which is expressed predominantly in the liver, is further processed into an N-terminal coiled-coil domain-containing chain and a C-terminal fibrinogen chain. The N-terminal chain is important for lipid metabolism, while the C-terminal chain may be involved in angiogenesis. Mutations in this gene cause familial hypobetalipoproteinemia type 2.






ANGPTL3 Antibody (PA5-28058) in WB

Western Blot using ANGPTL3 Polyclonal Antibody (Product # PA5-28058). HepG2 whole cell extract and conditioned medium (30 µg) was separated by 10% SDS-PAGE, and the membrane was blotted with ANGPTL3 Polyclonal Antibody (Product # PA5-28058) diluted at 1:500. The HRP-conjugated anti-rabbit IgG antibody was used to detect the primary antibody.

Western blot analysis of ANGPTL3 was performed by separating 10 µg of HepG2 conditioned medium by 10% SDS-PAGE. Proteins were transferred to a membrane and probed with a ANGPTL3 Polyclonal Antibody (Product # PA5-28058) at a dilution of 1:500. The HRP-conjugated anti-rabbit IgG antibody was used to detect the primary antibody.
