

This antibody is predicted to react with bovine, chicken, canine, human, mouse, non-human primate, Xenopus and zebrafish based on 100% sequence homology. In Western blot, this antibody detects a ~52 kDa protein representing GABA-A receptor beta 1 subunit from rat brain fractions.

GABA, the major inhibitory neurotransmitter in the vertebrate brain, mediates neuronal inhibition by binding to the GABA/benzodiazepine receptor and opening an integral chloride channel.
