This antibody is tested in Peptide ELISA: antibody detection limit dilution 64,000.

#### Background/Target Information

Proteins of the matrix metalloproteinase (MMP) family are involved in the breakdown of extracellular matrix in normal physiological processes, such as embryonic development, reproduction, and tissue remodeling, as well as in disease processes, such as arthritis and metastasis. Most MMP's are secreted as inactive proproteins which are activated when cleaved by extracellular proteinases. The enzyme encoded by this gene degrades proteoglycans, fibronectin, elastin and casein and differs from most MMP family members in that it lacks a conserved C-terminal protein domain. The enzyme is involved in wound healing, and studies in mice suggest that it regulates the activity of defensins in intestinal mucosa. The gene is part of a cluster of MMP genes which localize to chromosome 11q22. 3.



#### MMP7 Antibody (PA1-9069) in WB

Western blot was performed using Anti-MMP7 Polyclonal Antibody (Product # PA1-9069) and a 27 kDa band corresponding to MMP7 was observed. Whole cell extracts (30 µg lysate) of HT-29 (Lane 1), HT-29 treated with Protein Transport Inhibitor (PTI) cocktail (1X, 4 hours), SK-BR-3 (Lane 3) and SK-BR-3 treated with Protein Transport Inhibitor (PTI) cocktail (1X, 4 hours) (Lane 4) were electrophoresed using NuPAGE™ 10% Bis-Tris Protein Gel (Product # NP0301BOX). Resolved proteins were then transferred onto a Nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (0.03 µg /mL) and detected by chemiluminescence with Rabbit anti-Goat IgG Heavy Chain Superclonal™ Recombinant Secondary Antibody, HRP (Product # A27014,1:4000) using the iBright FL 1000 (Product # A32752). Chemiluminescent detection was performed using Novex® ECL Chemiluminescent Substrate Reagent Kit (Product # WP20005). Relative expression was observed between HT-29 and SK-BR-3, a cell line which is reported to express MMP7 at very low levels.
