Visfatin, also known as pre-B cell colony-enhancing factor, is an adipocytokine that is abundantly secreted by visceral adipose tissue, with insulin mimetic effects. Visfatin mimics insulin signaling by binding to the insulin receptor and reducing glucose release from liver cells, while stimulating glucose utilization in adipocytes and myocytes. Visfatin is also invoved in enhancement of cell proliferation, biosynthesis of nicotinamide mono-and dinucleotide and glucose homeostasis.







Western blot was performed using Anti-NAMPT Polyclonal Antibody(Product # PA5-34858) and a 55 kDa band corresponding to NAMPT was observed across cell lines tested. Increased expression of NAMPT was observed in HUVEC upon IL1-beta and TNF-alpha treatment. A non specific band around 60 kDa was also observed in HUVEC. Whole cell extracts (30 µg lysate) of HUVEC (Lane 1), HUVEC treated with IL1-beta (10 ng/mL for 18hr) (Lane 2), HUVEC treated with TNF-alpha (10 ng/mL for 18hr) (Lane 3) and U-87 MG (Lane 4) were electrophoresed using NuPAGETM 4-12% Bis-Tris Protein Gel (Product # NP0322BOX). Resolved proteins were then transferred onto a Nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (1:3000 dilution) and detected by chemiluminescence with Goat anti-Rabbit IgG (Heavy Chain) SuperclonalTM Recombinant Secondary Antibody, HRP (Product # A27036,1:4000 dilution) using the iBright FL 1000 (Product # A32752). Chemiluminescent detection was performed using Novex® ECL Chemiluminescent Substrate Reagent Kit (Product # WP20005).


