


### RhoF Antibody (PA5-31471) in IHC (P)

Immunohistochemical analysis of RHOF in paraffin-embedded colon carcinoma using a RHOF polyclonal antibody (Product # PA5-31471) at a dilution of 1:500.



### RhoF Antibody (PA5-31471) in WB

Western blot analysis of RhoF was performed by separating 50 µg of mouse tissue extract by 12% SDS-PAGE. Proteins were transferred to a membrane and probed with a RhoF Polyclonal Antibody (Product # PA5-31471) at a dilution of 1:500. The HRP-conjugated anti-rabbit IgG antibody was used to detect the primary antibody.

Western blot analysis of RHOF using 30  $\mu$ g of U87-MG lysate. Samples were loaded onto a 12% SDS-PAGE gel and probed with a RHOF polyclonal antibody (Product # PA5-31471) at a dilution of 1:500.
