It is a dual specificity protein kinase, catalyzing autophosphorylation and phosphorylation of exogenous substrates on both serine/threonine and tyrosine residues. The testicular germ cell-specific expression and developmental pattern of expression suggests a central role at and after the meiotic phase of spermatogenesis.
