Ubiquitination involves at least three classes of enzymes: ubiquitin-activating enzymes, or E1s, ubiquitin-conjugating enzymes, or E2s, and ubiquitinprotein ligases, or E3s. 



UBC9 Antibody (PA5-17043) in WB

Western blot was performed using Anti-UBC9 Polyclonal Antibody (Product # PA5-17043) and a 18 kDa band corresponding to UBC9 was observed across all the cell lines and tissues tested. Whole cell extracts (30 µg lysate) of HeLa (Lane 1), Hep-G2 (Lane 2), MCF7 (Lane 3), BJ (Lane 4), MDA-MB-231 (Lane 5), 3T3-L1 (Lane 6), 3T3-L1 differentiated to adipocytes (Lane 7), tissue extracts (30 µg lysate) of Mouse Spleen (Lane 8), Rat Spleen (Lane 9), Mouse Thymus (Lane 10) and Mouse Heart (Lane 11) were electrophoresed using NuPAGE® 4-12 % Bis-Tris gel (Product # NP0322BOX). Resolved proteins were then transferred onto a nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (1: 1,000 dilution) and detected by chemiluminescence with Goat anti-Rabbit IgG (Heavy Chain) SuperclonalTM Recombinant Secondary Antibody, HRP (Product # A27036, 1:4,000 dilution) using the iBright FL 1000 (Product # A32752). Chemiluminescent detection was performed using Novex® ECL Chemiluminescent Substrate Reagent Kit (Product # WP20005).

Antibody specificity was demonstrated by detection of differential basal expression of the target across cell models and tissues tested owing to their inherent genetic constitution. Higher expression of UBC9 was observed in MCF7, 3T3-L1, Mouse Spleen, Rat Spleen, Mouse Thymus in comparison to BJ, 3T3-L1 differentiated to adipocytes and Mouse Heart using Anti-UBC9 polyclonal antibody (Product # PA5-17043) in Western Blot.
